1. LOCAL FARMER

He points out that the use of manure in farming has allowed his farm to grow more crops than ever before. These crops stock the supermarkets in Tokyo and across the northern suburbs. Even more important, though, is that farming is a family business that has spanned six generations in the area.

2. OCEAN COTTAGE BED AND BREAKFAST

The suburb has always been a popular tourist destination. It used to be impossible to get a room at Ocean Cottage B&B without booking a year in advance, but lately she has plenty of open beds. Fewer and fewer people attend the local festivals because so few are able to catch anything.

3. OWNER OF TANAKA'S GENERAL STORE

Tanaka operates a store in the suburb and a few others in the surrounding area. He receives all of his produce from the local farmers and employs over 45 people. He prides himself on being able to deliver cheap goods that are grown locally and has been able to lower his prices during the farming boom.

4. OWNER OF NAKAMURA'S BAYSIDE RESTAURANT

He complains that runoff from the manure is killing the marine life in the Pacific Ocean. Lately he has not been able to keep enough seafood on hand at the restaurant to make some of his world famous dishes. As a result he's seen his profits decline by 15% and has been forced to raise prices.

5. PRESIDENT OF THE CHAMBER OF COMMERCE

The province has approached him with the proposed law. If the law fails to pass, the state will seek to build a new water purification plant in the suburb. The plant will only reduce a fourth of the manure runoff but it will create 100 new jobs for a town with a 15% unemployment rate.

6. OWNER OF THE LOCAL FISHING COMPANY
